THE REMOVAL OF WRECKS, 2007**

St. Vincent and the Grenadines Vessels:

A Wreck Removal Certificate may be issued for St. Vincent and the Grenadines vessels upon receipt of:

1. Written request from the registered Owners or Managers
2. Photocopy or Electronic Copy of the Blue Card issued by the Insurance company*
3. Payment of fees

Foreign Vessels:

A Wreck Removal Certificate may be issued for **Foreign vessels** upon receipt of:

1. Written request from the registered Owners or Managers
2. Photocopy or Electronic Copy of the Blue Card issued by the Insurance company*
3. Recent Transcript of Register from the Flag State
4. Letter of Consent for issue of the WRC from the Flag State
5. Payment of relevant invoice
